Terms of Use

1. There will be no food of any kind on the turf field, including gum, sunflower or other shelled seeds.
2. Water is the only beverage permitted on the turf field. Gatorade and other colored beverages, i.e., coffee, soda, etc. are strictly prohibited.
3. There are no sharp objects permitted on the turf surface, including but not limited to tent spikes, high heeled shoes, metal cleats, corner flags, chairs, benches, stages, or javelins. Footwear is restricted to molded cleats (max 1/2"), turf shoes, or other soled athletic shoes such as cross-trainers or running shoes.
4. The use of fireworks and/or open flames is strictly prohibited at the field.
5. There will be no use of tobacco / nicotine products including but not limited to: cigarettes, cigars, pipes, bidis, smokeless tobacco (chew, dip, snuff), and Electronic Nicotine Delivery Systems (e cigarettes, e cigars, e hookahs, e pipes) at the field. Use of cigarettes, cigars and pipes or the oral use of tobacco products are strictly prohibited on the field.
6. There will be no use of alcoholic beverages at the field.
7. The use or sale of illegal drugs including prescription drugs not intended for the user is strictly prohibited. Enforcement of School Zone criminal code will be applicable.
8. There will be no use of bikes, skateboards, roller skates, in-line skates, scooters or hover boards.
9. Pets are not permitted on the turf surface.
10. Noise levels must not exceed those stipulated by the City of Lancaster's local ordinance. Use of audio equipment including speakers, public address systems, amplification equipment or other devices are strictly prohibited or must be approved in advance by the Director of Operations.
11. No person shall use profane language on or within the field, or conduct themselves in any lewd, immoral or objectionable manner on or within the field. The user/applicant shall be responsible for the conduct of both participants and spectators alike.
12. No person shall peddle or solicit business, collect funds for any service or charity, distribute flyers or post advertising material including signs at the field. No person shall set up any booth, table or stand, mobile or otherwise, for the sale of any items including food and beverages within the limits of the field, with the exception of Boys & Girls Club of Lancaster sponsored events.

13. Trash receptacles are provided and clean-up is the responsibility of the applicant. The applicant is responsible for set-up, clean-up, and any damages to the facilities resulting from use of the facility. Clean-up includes, but is not limited to picking up litter, dumping garbage cans, cleaning up food and/or beverage spills. Clean-up area includes, but is not limited to playing area, turf surface, and spectator areas.
14. Glass containers of any kind are prohibited on the turf surface.
15. Damages will be assessed at the end of agreed rental period and are the responsibility of the renter.

Organizations not affiliated with the BGCL must secure and maintain at all times commercial general liability insurance, which shall be issued on an occurrence basis, with a limit of not less than one million dollars (\$1,000,000) per occurrence and in aggregate for bodily injury, death and property damage. At the signing of this contract, the organization must submit a certificate of insurance evidencing the required commercial general liability insurance policy, which shall list the organizations' name as the insured party and list the BGCL as an additional insured party. In addition, the certificate of insurance must include a waiver of subrogation.
